RELEASE OF ASSIGNMENT OF IP SECURITY AGREEMENT

THIS RELEASE OF ASSIGNMENT OF IP SECURITY AGREEMENT (this "Release") is made as of May 15, 2020 (the "Effective Date"), by BEARCUB ACQUISITIONS LLC, a Delaware limited liability company, with its principal place of business located at 400 Hamilton Avenue, Suite 3120, Palo Alto, California 94301 ("Bearcub") in favor of ARES VENTURES FINANCE, L.P., a Delaware limited partnership, with its principal place of business located at 245 Park Avenue, 44th Floor, New York, New York 10167 ("Ares").

WHEREAS, Interactions, LLC, as "Grantor", and Ares are parties to that Security Agreement (Intellectual Property) dated as of June 16, 2015 (the "IP Security Agreement"), pursuant to which Grantor granted to Ares a security interest in all of its right, title and interest in, to Trademarks (as defined in the IP Security Agreement);

WHEREAS, the Trademarks were recorded with the United States Patent and Trademark Office on June 24, 2015;

WHEREAS, pursuant to that Asset Purchase Agreement, dated as of November 1, 2017, by and between Ares Capital Corporation and Bearcub Acquisitions LLC, Ares has assigned to Bearcub all of its rights, remedies, duties and other obligations under, among other documents, the IP Security Agreement;

WHEREAS, pursuant to that Asset Purchase Agreement, Ares and Bearcub entered into the Assignment of IP Security Agreement (the "Assignment"), dated as of November 7, 2017;

WHEREAS, the Assignment and related trademarks under the IP Security Agreement were recorded with the United States Patent and Trademark Office on November 13, 2017 with the trademark assignment division at Reel 6204, Frame 0170.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bearcub, hereby agrees as follows:


