TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of July 6, 2020, is made by ESPRESSO CAPITAL LTD. (the “Lender”) under that certain Intellectual Property Security Agreement, dated as of July 23, 2019 between SOCIALCHORUS, INC., a Delaware corporation (the “Grantor”) and the Lender (as amended, supplemented or modified and in effect from time to time, the “IP Security Agreement”).

WHEREAS, pursuant to the IP Security Agreement the Grantor granted a security interest to the Lender in certain Intellectual Property collateral including the Trademarks set forth on Exhibit A thereto (the “IP Collateral”); and

WHEREAS, the IP Security Agreement was recorded with the Trademark Assignment Division of the United States Patent and Trademark Office on July 25, 2019 at Reel 006703, Frame 0846; and

WHEREAS, the Lender has agreed to terminate and release its security interest in all of such Trademarks and Patents, including, without limitation, the Trademarks and Patents identified on Schedule A attached hereto, being the same Trademarks and Patents set forth on Exhibit A to the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the IP Collateral, (b) release its security interest in the IP Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Lender in the IP Collateral.
