TRADEMARK ASSIGNMENT

Assignor does hereby, sell, assign, set over, transfer, and convey to Assignee the entire right, title, and interest in and to the Marks together with the goodwill of the business connected with the use of and symbolized by the Marks and all attendant rights, the same to be held and enjoyed by Assignee for its own use and enjoyment, and for use and enjoyment of its successors, assigns, or other legal representatives, as fully or entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made, together with all registrations of the Marks and all claims for legal and equitable relief of any kind by reason of past, present, or future infringement of said Marks, with the right to sue for and obtain the same for its own use and behalf, and for the use of its successors, or other legal representatives.


