This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of July 8, 2020, is made by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent (the "Administrative Agent"), under the Loan Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Loan Agreement).

**WHEREAS**, in connection with that certain Loan Agreement dated as of November 8, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), among Winnebago Industries, Inc., an Iowa corporation, (the "Company"), Octavius Corporation, a Delaware corporation, (the "Borrower"), the other Loan Parties from time to time party thereto, the Lenders party thereto and Administrative Agent, the Lenders have agreed to make loans and extend other financial accommodations to or for the benefit of the Borrower;

**WHEREAS**, the Company, the Borrower and the other Loan Parties have entered into a Pledge and Security Agreement dated as of November 8, 2016 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

**WHEREAS**, in connection with the Loan Agreement, Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "IP Security Agreements"), the Borrower and certain other Loan Parties granted security interests in the certain intellectual property owned by Borrower and the other Loan Parties, including those listed on Annex I attached hereto (the "IP Collateral"); and

**WHEREAS**, the IP Security Agreements were recorded in the U.S. Patent and Trademark Office or U.S. Copyright Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the IP Collateral, whether granted pursuant to the Security Agreement, the IP Security Agreements or any other agreement or document delivered in connection with the Loan Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the IP Collateral to Company and the other Loan Parties.

The Administrative Agent agrees, at Loan Parties' expense, to cooperate with Company and to provide Company with the information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
