RELEASE OF TRADEMARK SECURITY INTERESTS dated as of July 7, 2020 (this “Release”), by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Collateral Agent (the “Collateral Agent”). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreements, as applicable, referred to below.

A. Reference is made to (a) the Credit Agreement dated as of April 29, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “Credit Agreement”), among Quorum Health Corporation, a Delaware corporation (the “Borrower”), the Subsidiaries from time to time party thereto and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent and Collateral Agent, (b) the Guarantee and Collateral Agreement dated as of April 29, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “Guarantee and Collateral Agreement”), among the Borrower, the Subsidiaries from time to time party thereto and the Collateral Agent, (c) the Trademark Security Agreement dated as of April 29, 2016 among the Borrower, Quorum Health Resources, LLC, a Delaware limited liability company, Blue Island Hospital Company, LLC, a Delaware limited liability company (collectively, the “Initial Grantors”), and the Collateral Agent and (d) the Trademark Security Agreement dated as of December 28, 2016 ((c) and (d) together, the “Trademark Security Agreements” and, together with the Guarantee and Collateral Agreement, the “Security Agreements”), among QHCCS, LLC, a Delaware limited liability company (together, with the Initial Grantors, each individually a “Grantor” and collectively the “Grantors”) and the Collateral Agent.

B. Pursuant to the Security Agreements, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the Trademark Collateral, including without limitation the trademarks of the Grantors set forth on Schedule I hereto (collectively, the “Released Trademarks”), which security interest was recorded with the United States Patent and Trademark Office on April 29, 2016 at Reel 5781 Frame 0224 and on January 3, 2017 at Reel 5957 Frame 0455.

C. In connection with the termination of the Credit Agreement and the repayment, satisfaction, compromise, settlement, release or discharge of all Obligations and other amounts owing thereunder, the Grantors have requested that the Collateral Agent release all right, title and interest granted to it, for the benefit of the Secured Parties, under the Security Agreements in and to the Released Trademark Collateral (as defined in each respective Trademark Security Agreement).

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases, relinquishes and discharges any and all of its lien and security interests in and to all of the Grantor’s right, title and interest in, to and under the Trademarks, and re-assigns to the Grantors any and all right, title or interest it may have in such Released Trademark

Collateral under the Security Agreements. This Release is made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.

The Collateral Agent hereby authorizes each Grantor, or each Grantor's authorized representatives, to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Collateral Agent agrees to execute and deliver to the Grantors other instruments and other documents as may be necessary to release the lien on and security interest in the Trademarks which had been granted under the Trademark Security Agreement.


