TRADEMARK ASSIGNMENT

WHEREAS, Nygard Inc. has used and is the owner of the trademark "Allison Daley" in connection with women's and girl's apparel, which is the subject of United States Trademark Registration No. 1,523,606 (the "Trademark"); and

WHEREAS, Richter Advisory Group Inc. was appointed as receiver over properties, assets and undertakings of Nygard Holdings (USA) Limited, Nygard Inc., Fashion Ventures, Inc., Nygard NY Retail, LLC, 4093879 Canada Ltd., 4093887 Canada Ltd., Nygard International Partnership, Nygard Properties Ltd. and Nygard Enterprises Ltd., including the Trademark, pursuant to an order of the Manitoba Court of Queen's Bench (Winnipeg Centre) made on March 18, 2020, which has been recognized by a certain Chapter 15 Order Recognizing Foreign Main Proceeding and Related Relief made April 23, 2020 by the United States Bankruptcy Court, Southern District of New York (the "Receiver"); and

WHEREAS, Dillard's, Inc., a corporation duly organized under the laws of the State of Delaware and having its principal place of business at 1600 Cantrell Road, Little Rock, Arkansas 72201 ("Assignee"), desires to acquire all right, title and interest in and to the Trademark, the registration thereof, and the goodwill associated therewith; and


WHEREAS, pursuant to the Trademark Assignment Agreement dated July 3rd, 2020, between the Receiver and the Assignee, the Receiver agreed to assign and transfer the Trademark to Assignee.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Receiver hereby conveys and assigns to Assignee the entire right, title and interest in and to the Trademark together with all goodwill of the business represented and symbolized thereby with all rights to sue and recover damages and/or profits for past infringement, to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successor, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by the Receiver if this Assignment and sale had not been made.
