Pursuant to Section 10A-5A-2.02 of the Alabama Limited Liability Company Law of 2014, StrategyWise, LLC, an Alabama limited liability company (the "Company") hereby amends its Articles of Organization, as follows:



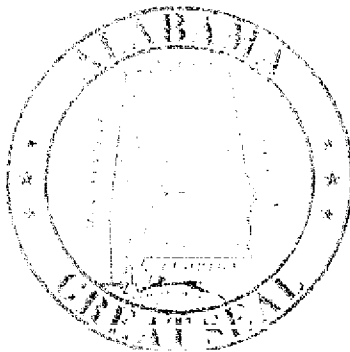
