TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is effective as of May 1, 2020 (the "Effective Date"), by and between 4th Generation, LLC, a North Carolina limited liability company having a principal place of business at 2601 Cloister Drive, Charlotte, NC 28211 ("Assignor"), and Arangold Corporation, an Illinois corporation having a principal place of business at 3170 Commercial Avenue, Northbrook, Illinois 60062 ("Assignee").

RECITALS

WHEREAS, Assignor is the sole owner of the 4TH GENERATION trademark, including U.S. Trademark Reg. No. 4,280,805, European Union Trade Mark Reg. No. 014737431, and all common law rights relating to the 4TH GENERATION trademark, along with the goodwill of the business associated therewith (together, the "Marks");

WHEREAS, Assignor and Assignee are parties to a certain Joint Ownership Agreement dated as of May 1, 2020, pursuant to which Assignee purchased an undivided 50% interest in the Marks from Assignor; and

WHEREAS, this Assignment memorializes the assignment of an undivided 50% interest in the Marks from Assignor to Assignee.

NOW, THEREFORE, for the consideration set forth in the Joint Ownership Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

AGREEMENT

1. Assignor hereby assigns and transfers to Assignee an undivided 50% the Marks, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same.
2. Assignor represents and warrants that: (a) it has not sold, licensed or otherwise granted any rights in or to the Marks to any third party; (b) there are no liens, security interests or other encumbrances on or against the Marks; (c) it has all authority necessary to enter into this Assignment; and (d) execution of this Assignment and the performance of its obligations hereunder shall not violate or conflict with any other agreement to which it is a party.
3. Assignor hereby requests the Commissioner for Trademarks at the United States Patent and Trademark Office, as well as his or her counterparts at the corresponding entities or agencies in any country or jurisdiction that may exercise authority over any of the Marks, to record this Assignment.
4. Assignor agrees to execute any additional documents, take other actions, and provide such other reasonable cooperation and assistance as reasonably needed to effectuate the intent of this Assignment.


