RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “*Release*”) is made effective as of July 9, 2020, by and between Cremo Company, LLC, a California limited liability company (the “*Grantor*”), and Kaylor Corporation, a California corporation (the “*Secured Party*”).

WHEREAS, the Grantor has granted security interests to the Secured Party under that certain Amended and Restated Subordinated Secured Promissory Note, dated as of May 17, 2019 (as amended, restated, or otherwise modified, the “*Security Agreement*”);

WHEREAS, the Grantor owns the trademarks (the “*Trademarks*”) listed on Schedule 1, which are registered or applied for with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to the Secured Party that certain Confirmatory Grant of Security Interest in Trademarks dated as of May 17, 2019 (the “*Trademark Security Agreement*”), which such Trademark Security Agreement granted a security interest in favor of the Secured Party in and to all of the Trademarks;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 20, 2019 at Reel 6649 / Frame 0236; and

WHEREAS, the Grantor has requested the Secured Party to release, and the Secured Party has agreed to release, its lien on and its security interest in and to all of the Trademarks.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. DEFINITIONS. All capitalized terms not defined herein shall have the respective meaning given to them in the Security Agreement.

2. RELEASE OF SECURITY INTEREST. The Secured Party hereby does terminate, release and discharge any and all liens and security interests that it may have, and all claims, whether presently existing or hereafter acquired or created pursuant to the Security Agreement or Trademark Security Agreement, in all of Grantor’s right, title and interest in and to the Trademarks set forth in Schedule 1.

3. GOVERNING LAW AND CONSTRUCTION. THE VALIDITY, CONSTRUCTION, AND ENFORCEABILITY OF THIS AGREEMENT SHALL BE GOVERNED BY THE INTERNAL LAWS OF THE STATE OF CALIFORNIA, WITHOUT GIVING EFFECT TO CONFLICT OF LAWS PRINCIPLES THEREOF.

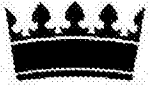
