ORDER APPROVING DEBTOR'S MOTION FOR AN ORDER AUTHORIZING
THE SALE OF THE MARK "THE BIG ONE" TO KOHL'S ILLINOIS, INC.

This matter is before the Court pursuant to the Debtor's Motion For An Order Authorizing The Sale Of The Mark "The Big One" To Kohl's Illinois, Inc. (doc. 1119) (the "Motion") filed by Roberds, Inc., the debtor and debtor in possession (the "Debtor").

The Court has reviewed the Motion and finds that good cause exists to grant the Motion.

The Court further finds that: (a) it has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) this is a core proceeding; and (c) notice of the Motion was sufficient under the circumstances.

It further appears to the Court that no timely written (1) objections to the Motion or (2) higher and better bids were filed.

It is therefore ORDERED that:


1. The Motion is granted.
2. The Debtor is authorized to sell and assign the Mark (as defined in the Motion) to Kohl's Illinois, Inc., "as is" and without any warranties, except that the Debtor represents that it has not previously assigned or transferred the Mark, free and clear of any liens and encumbrances, upon a cash payment to the Debtor in the amount of \$20,000.00.

3. The Debtor is authorized to execute the Assignment of the Mark attached as Exhibit 2 to the Motion.

4. This Order is binding upon any trustee or examiner whether appointed or elected in this or a succeeding case.
