TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Trademark Assignment"), dated as of March 5, 2020, is made by Bosch Automotive Service Solutions Inc., a Delaware Corporation, with a place of business 28635 Mound Road, Warren, Michigan 48092 (hereafter "Assignor"), in favor of Beissbarth GmbH, with an address of Hanauer Straße 101, Munich, Germany 80993, (hereafter "Assignee").

- (a) the trademark application set forth on Schedule A hereto, (the "Assigned Trademark"), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademark;
- (b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction;
- (c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
- (d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the

right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.




