TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made on this 10th day of July, 2020 by Brand Funding, LLC, in its capacity as administrative agent for itself and the other lenders (in such capacity, the “Agent”).

WHEREAS, pursuant to (i) that certain Security Agreement dated as of May 21, 2020, by and among, among others, Brooks Brothers Group, Inc., a Delaware corporation, Golden Fleece Manufacturing Group, LLC, a Delaware limited liability company (each individually, a “Grantor”, and collectively, the “Grantors”) and Agent and (ii) that certain Grant of Security Interest in United States Trademarks dated as of May 21, 2020, by and between the Grantors and Agent (the “Trademark Grant”), the Grantors pledged and granted the Agent a lien on and security interest in and to all of its right, title and interest in all Marks, including, without limitation, those certain Marks identified on Exhibit A attached hereto, all Proceeds and products of the Marks, the goodwill of the businesses with which the Marks are associated, and all causes of action arising prior to or after May 21, 2020, for infringement of any of the Marks or unfair competition regarding the same (collectively, the “Released Marks Collateral”). Capitalized terms used herein but not otherwise defined shall have the meaning given such terms in the Trademark Grant.

WHEREAS, the Trademark Grant was recorded at the United States Patent and Trademark Office (the “USPTO”) on May 21, 2020 on Reel 6943 and Frame 0767.

WHEREAS, the Agent has agreed to terminate and release all of its interest in and to the Released Marks Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby irrevocably terminates, releases and discharges all liens, security interests and any other rights that are or may have been granted to the Agent in and to the Released Marks Collateral.

The Agent agrees to provide the Grantors with any information and additional authorization necessary to effect the release of Agent’s security interest in the Released Marks Collateral.

The Agent shall, at the sole cost and expense of Grantors, execute and deliver to Grantors all further releases and other documents, and take all other actions reasonably necessary for the release of such security interest. The Agent authorizes and requests that the USPTO note and record the existence of the release hereby given.

The Agent agrees that any power of attorney or similar rights granted by the Grantors to the Agent with respect to the Released Marks Collateral pursuant to or in connection with the Trademark Grant is terminated.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
