ASSIGNMENT OF TRADEMARK RIGHTS

WHEREAS, A TO Z DISTRIBUTOR, INC., a California corporation, having its principal place of business at 1612 N. Indiana St., Los Angeles, CA 90063, ("Assignor"), began using the ROYAL FRAGRANCE trademark on June 10, 2012 for Aftershave; Body lotion; Body wash; Cologne; Eau de cologne; Perfume; all the foregoing not relating to sports or a sports team, league, mascot or stadium and first used the ROYAL FRAGRANCE trademark in commerce on the same date, June 10, 2012 for the same goods (hereinafter, "the Trademark"). WHEREAS, upon the formation of Royal Global Distribution, Assignor assigned to Royal Global Distribution Inc. its entire right, title, and interest in the Trademark and all goodwill represented by said Trademark, including the right to sue for past, present, and future damages. This written assignment is a memorialization of the oral assignment, implied assignment, and assignment through conduct that occurred on May 4, 2018 when Assignor transferred its business operations to Royal Global Distribution Inc.

WHEREAS, Royal Global Distribution Inc ("Assignee"), a California corporation, located at 1612 N Indiana St., Los Angeles, CA 90063 ("Assignee") desires to acquire, and has acquired, all of Assignor's right, title, and interest in and to the Mark, and the goodwill represented by the Trademark, prior to its own use.

NOW THEREFORE, in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor by these presents do hereby sell, assign, transfer and convey to Assignee, and the Assignee does hereby accept from Assignor, all of Assignor's right, title, and interest in and to the Mark, together with the goodwill represented by and associated with the Trademark and the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to said Mark or the registration thereof or such associated goodwill.
