- (1) **CAMBRIDGE BROADBAND NETWORKS LIMITED (IN ADMINISTRATION)** (No. 03879840) whose registered office is at 55 Baker Street, London W1U 7EU acting by the Administrators (defined below) (Assignor);
- (2) **ANTONY DAVID NYGATE and COLIN MICHAEL TREVETHYN HAIG** of BDO LLP, 55 Baker Street, London W1U 7EU (together the Administrators); and
- (3) **CAMBRIDGE BROADBAND NETWORKS GROUP LIMITED** (No. 10427528) whose registered office is at 1 Hammersmith Broadway, London W6 9DL (Assignee).

BACKGROUND

- (A) The Administrators were appointed joint administrators of the Assignor by a Notice of Appointment of an Administrator filed at Court on 6 February 2020.

Business	means the business of the design, installation, support and servicing of fixed wireless access microwave and millimeter wave technology carried on by the Assignor prior to the appointment of the Administrators
Completion Date	19 March 2020
Intellectual Property Rights	such trademarks, patents, design rights, registered designs, copyright, database rights, rights to inventions and domain names, rights in computer software, rights in confidential information and know how and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world

IPR Assets

all Intellectual Property Rights owned, used or held for use by the Assignor including but not limited to the domain names, trade marks and patents specified in Schedule 1
