**RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of July 14, 2020 (the “Effective Date”), is made by Credit Suisse AG, Cayman Islands Branch, in its capacities as administrative agent and collateral agent (in such capacities, the “Agent”), in favor of Shift4 Payments, LLC, a Delaware limited liability company (“Shift4”), POSitouch, LLC, a Rhode Island limited liability company (“POSitouch”), Future POS, LLC, a Pennsylvania limited liability company (“Future POS”), Merchant-Link, LLC, a Delaware limited liability company (“Merchant Link”) and Shift4 Corporation, a Nevada corporation (“S4 Corp” and, together with Shift4, POSitouch, Future POS and Merchant Link, each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Second Lien Pledge and Security Agreement, dated as of November 30, 2017, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), each Grantor granted to the Agent, for the benefit of the Secured Parties, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement (i) Shift4, POSitouch, Future POS and S4 Corp executed and delivered a Second Lien Intellectual Property Security Agreement, dated as of November 30, 2017 and recorded with the United States Patent and Trademark Office on December 4, 2017 at Reel/Frame 6219/0150 and (ii) Merchant Link delivered a Second Lien Intellectual Property Security Agreement, dated as of December 13, 2019 (together, the “Intellectual Property Security Agreements”), and recorded with the United States Patent and Trademark Office on December 26, 2019 at Reel/Frame 6826/0017;

WHEREAS, the Agent now desires to terminate and release the security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Intellectual Property Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto, arising under the Security Agreement and the Intellectual Property Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Intellectual Property Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Intellectual Property Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by any Grantor, at such Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.


