**DECLARATION PURSUANT TO 37 C.F.R. § 2.20  
IN SUPPORT OF REMOVAL OF TRADEMARK  
ASSIGNMENT RECORDED AT REEL/FRAME 6863/0876**

I, Sana Hakim, Attorney of Record for Farmwise, LLC, hereby declare:

1. The attached Assignment of Trademarks document (“Assignment”) dated February 13, 2020, recorded at Reel/Frame 6863/0876, was filed in error by prior counsel for Farmwise, LLC.
2. The Assignment was recorded against the below Trademarks, which are currently in the name of Farmwise, LLC, a Delaware limited liability company:

3. The parties to the Assignment did not intend to assign the listed Trademarks, but rather intended to correct the state of formation of Assignor.
4. The applications for the Trademarks were inadvertently filed in the name of Farmwise, LLC, a *Massachusetts* limited liability company. The applications for the Trademarks should have been filed in the name of Farmwise, LLC, a *Delaware* limited liability company.
5. Because the Assignor listed in the Assignment, Farmwise, LLC, a Massachusetts limited liability company, does not exist, the Assignment is not valid. The ownership of the Trademarks has not changed and they are still owned by Farmwise, LLC, a Delaware limited liability company.
6. Accordingly, pursuant to TMEP 503.06, the Attorneys for Farmwise, LLC, a Delaware LLC, hereby request that this corrective document be recorded to remove the recordal of the Assignment of Trademarks at Reel/Frame 6863/0876.
