TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of May 14, 2020, and made by SIENA LENDING GROUP LLC, having an office at 9 W Broad Street, 5th Floor, Stamford, Connecticut 06902 ("Grantor") to COVER FX SKIN CARE INC. (the "Grantee"), having an address at 168 Fifth Avenue, Suite 201, New York, NY, 10010.

WHEREAS, pursuant to that certain Security Agreement dated as of July 11, 2017, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Intellectual Property Collateral (as hereinafter defined);

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Trademarks The Grantor is the owner of various trademarks including the trademarks set forth in Schedules "A" and "C", the registrations and applications for the trademarks identified therein, and the underlying goodwill associated with the trademarks (collectively, the "Trademarks").

2. Copyrights The Grantor is the owner of various copyrights including the copyright registrations set forth in Schedule "B" (collectively, the "Copyrights", and together with the Trademarks, the "Intellectual Property Collateral").


3. Definitions The term "Intellectual Property Collateral," as used herein, shall include, but is not limited to, all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks and Copyrights.

4. Release of Security Interest Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property Collateral and confirms that the Grantor is entitled to all right, title and interest in the Intellectual Property Collateral.
