## CONFIRMATORY ASSIGNMENT

This confirmatory assignment (“Assignment”), effective as of June 28, 2018 (the “Effective Date”), is made from SOURCECORP BPS INC., a Delaware corporation (“Assignor”), having a business address at 2701 E Grauwylers Rd, Irving, Texas, 75061, to DELIVEREX, LLC, a Delaware limited liability company (“Assignee”), having a business address at 2701 E Grauwylers Rd, Irving, Texas, 75061.

NOW, THEREFORE, for valuable consideration the receipt and sufficiency of which are hereby acknowledged, Assignor hereby conveys, transfers and assigns to Assignee, *nunc pro tunc* effective as of the Effective Date, any and all rights, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, and the Registration.

Assignor agrees that at any time and from time to time after execution of this Assignment, at the request of Assignee and without further consideration, Assignor will execute and deliver such other instruments and take such action as Assignee may reasonably request to transfer, convey and assign to Assignee, and to confirm Assignee's right, title and interest in and to the Mark and

Registration and to assist Assignee in exercising all rights with respect to the Mark and Registration.

Nothing in this Assignment, express or implied, is intended or will be construed to confer upon, or give to, any person or entity, other than the parties to this Assignment, any rights, remedies, obligations or liabilities. This Assignment will bind and inure to Assignee and Assignor and their respective successors and assigns. This Assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same.
