Assignor does hereby convey, transfer and assign to Assignee, as of the Effective Date, all Assignor's right, title, and interest in and to the Trademarks listed in SCHEDULE A and all issuances, extensions and renewals thereof, together with any and all goodwill of the business associated with the use of, and symbolized by, the Trademarks, all common law rights associated with the Trademarks, and all applications and registrations of the Trademarks, as well as any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the Effective Date hereof, including all rights to and claims for damages, and profits, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages and the right to sue for and recover the same in Assignee's own name and the names of Assignee's successors, assigns, or other legal representatives, the same to be held and enjoyed by said Assignee and its successors, legal representatives and assigns, as fully and entirely as the same would have been held by Assignor had this Assignment not been made.

This Assignment is to be governed and construed in accordance with the laws of the State of Ohio, without regard to any applicable principles of conflicts of laws.
