INTELLECTUAL PROPERTY SECURITY AGREEMENT

For valuable consideration as further described in the US Security Agreement supplemented hereby, **UNI-SELECT INC.**, a Quebec corporation (the “**Canadian Grantor**”) and **UNI-SELECT USA HOLDINGS, INC.**, a Delaware corporation, **UNI-SELECT USA, INC.**, a Delaware corporation, **4549009, INC.**, a Delaware corporation, **UNI-SELECT LLC**, a Delaware limited liability company, **FINISHMASTER, INC.**, an Indiana corporation, **FINISHMASTER SERVICES, INC.**, an Indiana corporation, **GEARHEAD PRODUCTS, INC.**, an Indiana corporation, and **AUTOMOTIVE INFORMATION MANAGEMENT, INC.**, a Georgia corporation (each of which is a “**US Grantor**” and collectively with the Canadian Grantor are the “**Grantors**” and individually, a “**Grantor**”), agrees with **NATIONAL BANK OF CANADA**, as Collateral Agent (the “**Collateral Agent**”), a bank existing under the Bank Act (Canada) having an office at 1155 Metcalfe Street, 5th floor, Montréal, Québec H3B 4S9) as follows:

SECTION 1. DEFINITIONS.

In this Agreement, the following terms shall have the following meanings (capitalized terms not otherwise defined herein shall have the meanings ascribed thereto in the US Security Agreement as defined below):

“**Canadian Security Agreement**” means the Security Agreement, dated June 26, 2020, among *inter alios* the Canadian Grantor and the Collateral Agent, as amended and supplemented from time to time.

“**Copyright Licenses**” means any and all agreements providing for the granting of any right in or to Copyrights (whether any Grantor is licensee or licensor thereunder).

“**Copyrights**” means all United States and foreign copyrights (including Community designs), including, without limitation, copyrights in software and databases, and all Mask Works (as defined under 17 U.S.C. §901 of the U.S. Copyright Act), whether registered or unregistered, and, with respect to any and all of the foregoing: (i) all registrations and applications therefor including, without limitation, the registrations and applications referred to Exhibit A-III hereto, (ii) all extensions and renewals thereof, (iii) all rights corresponding thereto throughout the world, (iv) all rights to sue for past, present and future infringements thereof and (v) all Proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages and proceeds of suit.

“**Intellectual Property**” means, collectively, the Copyrights, the Copyright Licenses, the Patents, the Patent Licenses, the Trademarks, the Trademark Licenses, the Trade Secrets, and the Trade Secret Licenses.

“**Patent Licenses**” means all agreements providing for the granting of any right in or to Patents (whether any Grantor is licensee or licensor thereunder).

“Patents” means all United States and foreign patents and certificates of invention, or similar industrial property rights, and applications for any of the foregoing, including, without limitation: (i) each patent and patent application referred to in Exhibit A-I hereto, (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals, and reexaminations thereof, (iii) all rights corresponding thereto throughout the world, (iv) all inventions and improvements described therein, (v) all rights to sue for past, present and future infringements thereof, (vi) all licenses, claims, damages, and proceeds of suit arising therefrom, and (vii) all Proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit.

“Security Agreements” means the US Security Agreement together with the Canadian Security Agreement and **“Security Agreement”** means either of them, as applicable.

“Trademark Licenses” means any and all agreements to which any Grantor is a party providing for the granting of any right in or to Trademarks (whether a Grantor is licensee or licensor thereunder).

“Trademarks” means all United States and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing including, without limitation: (i) the registrations and applications referred to in Exhibit A-II hereto, (ii) all extensions or renewals of any of the foregoing, (iii) all of the goodwill of the business connected with the use of and symbolized by the foregoing, (iv) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill, and (v) all Proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit”; provided, however, any application for registration of a trademark filed by a Grantor with the United States Patent and Trademark Office (“USPTO”) on an intent-to-use basis shall be excluded from the Trademarks (whether or not listed on Exhibit A-II) until such time as a statement to use or amendment to allege use is accepted by the USPTO, at which time such application and trademark shall automatically become part of the Trademarks and subject to the security interest granted hereunder.

“Trade Secret Licenses” means any and all agreements to which any Grantor is a party providing for the granting of any right in or to Trade Secrets (whether a Grantor is licensee or licensor thereunder).

“Trade Secrets” means all trade secrets and all other confidential or proprietary information and know-how whether or not such trade secret has been reduced to a writing or other tangible form, including all documents and things embodying, incorporating, or referring in any way to such trade secret, including, without limitation,: (i) the right to sue for past, present and future misappropriation or other violation of any Trade Secret, and (ii) all Proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit.

“**US Security Agreement**” means the US Security Agreement, dated June 26, 2020, among *inter alios* the US Grantors and the Collateral Agent, as amended and supplemented from time to time.

SECTION 2. REAFFIRMATION OF SECURITY AGREEMENTS; SUPPLEMENTAL GRANT OF SECURITY INTEREST.

Each Grantor acknowledges, reaffirms and ratifies in all respects the Security Agreement applicable to it as though all provisions thereof were fully set forth in this Agreement, including, without limitation, the grant by each Grantor of a security interest in all Intellectual Property included in the Collateral, as such term is defined in such Security Agreement.


Without limiting the generality of the foregoing, to secure the payment and other performance of the Secured Obligations, each Grantor grants to the Collateral Agent a security interest in, and assigns, pledges and hypothecates to the Collateral Agent, all right, title and interest of each Grantor in and to, wherever located, whether now owned or hereafter acquired or now existing or hereafter arising or accruing and whether or not subject to Article 9 of the Uniform Commercial Code or described in the Perfection Certificate or any supplement thereto hereafter delivered to the Collateral Agent by each Grantor, (i) Intellectual Property (including, without limitation, all Intellectual Property described on Exhibit A-I (Patents), Exhibit A-II (Trademarks) and Exhibit A-III (Copyrights) attached to and made a part of this Agreement), (ii) Supporting Obligations incident to, arising or accruing pursuant to or otherwise relating to any Intellectual Property, whether arising or accruing from any action taken by each Grantor or the Collateral Agent or otherwise, (iii) Proceeds, other proceeds and products of any of the things referred to in clauses (i) and (ii) of this sentence and (iv) Records relating to any of the things referred to in any of the foregoing clauses.

SECTION 3. GOVERNING LAW.

This Agreement shall be governed by and construed, interpreted and enforced in accordance with the law of the State of New York (including, without limitation, Sections 5-1401 and 5-1402 of the General Obligations Law of the State of New York) and, to the extent applicable, the federal law of the United States without regard to the law of any other jurisdiction.
