**NOTICE OF AGENCY RESIGNATION AND ASSIGNMENT OF
TRADEMARK SECURITY AGREEMENT**

THIS NOTICE OF RESIGNATION AND ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT (this “Assignment”) is made and entered into as of July 14, 2020 by **BARCLAYS BANK PLC**, as the resigning Collateral Agent (in such capacity, “Assignor”), in favor of **WILMINGTON SAVINGS FUND SOCIETY, FSB**, not in its individual capacity but solely as successor Collateral Agent, with an of address 500 Delaware Avenue, Wilmington, DE 19801, as the successor administrative agent (in such capacity, “Assignee”).

W I T N E S S E T H

WHEREAS, Assignor is party to that certain First Lien Security Agreement, dated as of April 28, 2014 (as supplemented by Supplement No. 1, dated as of April 29, 2014 and Supplement No. 2, dated as of September 30, 2014, in favor of the Assignor, and as may be further restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), among Evergreen Skills Intermediate Lux S.à r.l., a private limited liability company, incorporated under the laws of Luxembourg, Evergreen Skills Lux S.à r.l., a private limited liability company, incorporated under the laws of Luxembourg, each of the subsidiaries party thereto (the “Grantors”) and Assignor;

WHEREAS, pursuant to (i) the Security Agreement, (ii) the First Lien Grant of Security Interest in Trademark Rights made by Skillsoft Ireland Limited and Skillsoft Limited in favor of Assignor recorded at the United States Patent and Trademark Office (the “USPTO”) on April 29, 2014 at Reel/Frame 5271/0222 and (iii) the First Lien Grant of Security Interest in Trademark Rights made by Amber Holding Inc., SumTotal Systems LLC, Softscape Software LLC, GeoLearning, Inc., Accero, Inc., Cybershift Holdings, Inc. and Cybershift, Inc. in favor of Assignor recorded at the USPTO on September 30, 2014 at Reel/Frame 5373/0406 (each, a “Trademark Security Agreement” and together, the “Trademark Security Agreements”), the Grantors granted to Assignor a security interest in and to the Collateral (as defined in each Trademark Security Agreement), including the trademark registrations and applications to register trademarks set forth on Schedule I (the “Assigned Trademark Collateral”);

WHEREAS, pursuant to that certain Resignation, Waiver, Consent and Appointment Agreement (“Agent Assignment”), dated as of May 29, 2020, among the Grantors, the other parties thereto, Assignor and Assignee, Assignor resigned as Administrative Agent under the Credit Agreement and other Loan Documents, and Assignee accepted its appointment as such under the Credit Agreement and other Loan Documents, and Assignor assigned and transferred to Assignee each of the Liens and security interests granted to the Assignor under the Loan Documents; and

WHEREAS, Assignor and Assignee desire to enter into this Assignment to evidence the resignation of Assignor as the Administrative Agent, the appointment of Assignee as the Administrative Agent, and the assignment by Assignor to Assignee of the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby covenant and agree as follows:

1. Terms. Capitalized terms used in this Assignment and not otherwise defined herein shall have the meanings as specified or otherwise used in the Agent Assignment.
2. Assignment. Assignor hereby transfers, assigns, grants and conveys to Assignee for the ratable benefit of the Secured Parties all of its right, title and interest in, to and under the Security Agreement and

the Trademark Security Agreement, including, without limitation, its security interest in, and Lien on, the Assigned Trademark Collateral, and Assignee hereby accepts and assumes the foregoing assignment and all of such right, title, interest, security interests and Lien.

3. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.


