## PLAN OF CONVERSION

Pursuant to the provisions of O.C.G.A. § 14-11-212, KABOBS ACQUISITION, INC., a Georgia corporation (the "Corporation"), enters into a plan of conversion to become a Georgia limited liability company in accordance with this Plan of Conversion, such Plan of Conversion having been adopted by the Board of Directors and approved by the Shareholders of the Corporation.

### ARTICLE I NAME

The name of the Georgia limited liability company to be formed pursuant to the election described herein shall be KABOBS ACQUISITION, LLC (the "Company").

### ARTICLE II EFFECTIVE TIME OF ELECTION

The effective date and time of such election shall be the date and time of filing of the Certificate of Conversion.

### ARTICLE III ARTICLES OF ORGANIZATION

The Articles of Organization of the Company shall be filed in the State of Georgia, in accordance with the laws of the State of Georgia, and in the form attached hereto as Exhibit A.

### ARTICLE IV CONVERSION OF INTERESTS

The manner and basis for converting the shares of the Shareholders in the Corporation into ownership interests as Members of the Company shall be on a pro rata basis, meaning that the resulting ownership interests held by each Member of the Company immediately after the election contemplated herein shall be the same as that held in the Corporation immediately prior to such election. Approval of the election contemplated herein by those persons who will be Members of the Company immediately after such election will be deemed to be execution of the Operating Agreement of the Company.


