TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made effective as of the date of its execution below by Trader Interactive, LLC, a Florida limited liability company ("Assignor"), with a principal office at 999 Waterside Drive, Suite 1900, Norfolk, Virginia 23510, in favor of TPI Holdings, Inc., a Delaware corporation ("Assignee"), with a principal office at 150 Granby Street, Norfolk, Virginia 23510.

RECITALS:

WHEREAS, Assignor (f/k/a Dominion Web Solutions, LLC) and Assignee are parties to that certain Second Amended and Restated License Agreement dated as of December 31, 2016 ("License Agreement");

WHEREAS, in accordance with its rights under the License Agreement, Assignor has adopted and uses and promotes the service marks TRADER INTERACTIVE and TRADER TRAXX (collectively, "Marks");

WHEREAS, as shown in Exhibit A attached hereto, Assignor has applied to register the Marks with the United States Patent and Trademark Office under Application Serial No. 88685535 for TRADER INTERACTIVE and Application Serial No. 88685524 for TRADER TRAXX (collectively, "Applications") (the Marks and the Applications are referred to collectively herein as the "Assigned Property"); and

WHEREAS, under the License Agreement, (a) Assignee is to be the owner of the Marks, (b) the Applications have been made by Assignor for and on behalf of Assignee, and (c) Assignee has granted Assignor an exclusive license with respect to the Marks ("Exclusive License");

WHEREAS, in furtherance of Assignee's rights under the License Agreement, Assignor desires to assign the Marks to Assignee, with Assignor reserving all of its rights in respect of its Exclusive License to the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers, and sets over to Assignee any and all of Assignor's ownership rights in and to the Assigned Property, together with the goodwill associated with such ownership, including any extensions or renewals thereof that are or may be secured under the laws of the United States now or hereafter in effect, subject to, and expressly excluding Assignor's rights in respect of, the Exclusive License.

This Assignment is deemed to be executed within the Commonwealth of Virginia and will be construed, interpreted, and applied in accordance with the laws of the Commonwealth of Virginia without regard to its conflicts-of-law principles.
