RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of July 16, 2020, is executed by KAYNE SENIOR CREDIT III LOANCO, LLC, a Delaware limited liability company, in its capacity as Administrative Agent (in such capacity, “Administrative Agent”), in favor of HASA, INC., a California corporation (“Hasa”), and INTER VALLEY POOL SUPPLY, INC., a California corporation (“IVPS”, and together with Hasa, “Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreements (as defined below).

RECITALS

A. WHEREAS, (i) Hasa has, pursuant to that certain Trademark Security Agreement dated October 31, 2017, recorded in the United States Patent and Trademark Office (the “USPTO”) on October 31, 2017 at Reel 006194, Frame 0143 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “2017 Security Agreement”) and (ii) IVPS has, pursuant to that certain Trademark Security Agreement dated April 19, 2018, recorded in the USPTO on April 20, 2018 at Reel 006317, Frame 0689 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “2018 Security Agreement”, and together with the 2017 Security Agreement, the “Security Agreements”), granted to Administrative Agent a security interest in and to all of Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Administrative Agent wishes to terminate and release its security interest in and to the Released Collateral as provided in this release.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby terminates and releases, without recourse its security interest in and to the Released Collateral and terminates the Security Agreements. Administrative Agent represents and warrants that: (i) it has the full power and authority to execute this Release and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreements. Administrative Agent acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of Grantor. The Administrative Agent authorizes Grantor, or its designee, to record this Release with the USPTO and other applicable registry at the sole expense of Grantor and agrees to provide Grantor with any information and additional authorization necessary to effect the release of the security interest in the Released Collateral.
