TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 17, 2020 (“Release”), is made by Cadence Bank (“Lender”) in favor of BigMouth, LLC, an Indiana limited liability company (“Pledgor”).

WHEREAS, pursuant to that certain Security Agreement dated as of November 14, 2016 (as amended, restated, amended and restated, extended, supplemented or otherwise modified in writing time to time, the “Security Agreement”) by Pledgor and BigMouth Inc., an Indiana corporation, in favor of Lender, Pledgor granted to and for the benefit of Lender, a continuing security interest in any and all right, title and interest of Pledgor in and to the trademarks listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Pledgor executed and delivered to and for the benefit of Lender, the Trademark Security Agreement recorded at the United States Patent and Trademark Office (“USPTO”) on December 9, 2016 at Reel 5944 Frame 0525 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Pledgor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:


(a) terminates, cancels, discharges, and releases the continuing security interest in any and all right, title and interest of Pledgor in and to the Trademark Collateral granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor’s expense.
