## CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS

This CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of July 17, 2020, is given by QUICK ATTACH ATTACHMENTS, LLC, a limited liability company organized under the laws of the State of Minnesota (the “Grantor”), in favor of ASSOCIATED BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as administrative agent for the lenders as defined in the Security Agreement described below (the “Secured Party”).

### WITNESSETH:

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of July 17, 2020 made and given by the Grantor, among others, to the Secured Party (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, replaced, supplemented or otherwise modified from time to time, the “Security Agreement”), Grantor has granted a security interest in its assets to secure its obligations to the Secured Party;

WHEREAS, pursuant to the Security Agreement, the Grantor is required to execute and deliver to the Secured Party, this Confirmatory Grant of Security Interest in Trademarks;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby agrees as follows:

1. **DEFINED TERMS.** All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

2. **GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL.** The Grantor hereby grants to the Secured Party a continuing first priority security interest in all of the Grantor’s right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the “Trademark Collateral”):

(a) all of its trademarks and trademark licenses to which it is a party including those referred to on Schedule I hereto;

(b) all reissues, continuations or extensions of the foregoing;

(c) all goodwill of the business connected with the use of each trademark and each trademark license; and

(d) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any trademark or trademark licensed under any trademark license or (ii) injury to the goodwill associated with any trademark or any trademark licensed under any trademark license.

3. SECURITY AGREEMENT. The security interests granted pursuant to this Confirmatory Grant of Security Interest in Trademarks are granted in conjunction with the security interests granted to the Secured Party pursuant to the Security Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. Unless and until an Event of Default occurs and is continuing, the Grantor shall retain the legal and equitable title to the Trademarks, and shall have the right to use and register the Trademarks in the ordinary course of the business of the Grantor, subject to the terms of the Security Agreement.
