INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (the “Assignment”), dated as of July 17, 2020, and effective as of 10:01 a.m. Wilmington, Delaware, time, is by and between Surgalign Spine Technologies, Inc. (formerly known as RTI Surgical, Inc.), a Delaware corporation (“Assignor”), and RTI OEM, LLC, a Delaware limited liability company (“Assignee”).

WHEREAS, RTI Surgical Holdings, Inc., a Delaware corporation (“Parent”), and Ardi Bidco Ltd., a Delaware corporation (“Buyer”) have entered into an Equity Purchase Agreement dated January 13, 2020 (as amended from time to time, the “Purchase Agreement”) pursuant to which Parent and its Subsidiaries (as defined in the Purchase Agreement) agreed to sell to Buyer, and Buyer desires to purchase from the Subsidiaries of Parent, all of the Securities (as defined in the Purchase Agreement); and

WHEREAS, in furtherance of the transactions contemplated by the Purchase Agreement, Assignor desires to assign the intellectual property listed on the attached Schedules A and B (the “Assigned IP”) to Assignee.

NOW, THEREFORE, in consideration of the foregoing, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment of Trademarks. Pursuant to the Purchase Agreement, Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee and Assignee accepts all right, title and interest of Assignor, to be held and enjoyed by Assignee as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, as assignee of its respective entire right, title and interest therein, in and to (i) certain trademarks and trademark applications set forth in Schedule A hereto, together with the goodwill of the business symbolized thereby; (ii) all renewals and extensions of any such application, registration and filing; (iii) all rights in and to all income, royalties and payments now or hereafter due or payable with respect thereto, (iv) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing and (v) all rights corresponding to any of the foregoing throughout the world.
2. Assignment of Patents. Pursuant to the Purchase Agreement, Assignor sells, transfers, conveys, assigns and delivers to Assignee and Assignee accepts all right, title and interest of Assignor, to be held and enjoyed by Assignee (and its successors and assigns) for its use and enjoyment and the use and enjoyment of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, as assignee of its respective entire right, title and interest therein, in and to (i) the patents and patent applications set forth in Schedule B hereto; (ii) patents which may be granted from divisionals, reissues, continuations, continuations-in-part, reexaminations, and foreign counterparts claiming priority to the underlying said patent rights; (iii) all rights in and to all income, royalties and payments now or hereafter due or payable with respect thereto, (iv) all rights to sue for

past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing and (v) all rights corresponding to any of the foregoing throughout the world.

3. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office, and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Following the date hereof, upon Assignee's reasonable request, and at Assignee's cost and expense, Assignor shall take such steps and actions, including the execution and delivery of any affidavits, declarations, oaths, assignments, or powers of attorney necessary to effect, evidence, or perfect the assignment of the Assigned IP to Assignee.
4. Successors. This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of Assignor and Assignee.
5. Governing Law. This Assignment shall be governed by, and construed in accordance with (i) the laws of the United States, in respect to trademark, patent and copyright issues, and (ii) in all other respects, including as to validity (except for patent, trademark and copyright issues), interpretation and effect, by the laws of the State of Delaware without giving effect to the conflict of laws rules thereof.
6. Counterparts. This Assignment may be executed in separate counterparts, each of which is deemed to be an original and all of which taken together constitute one and the same agreement.
7. Miscellaneous. This Assignment is subject to all the terms and conditions of the Purchase Agreement. The parties intend that this Assignment is for recordation purposes only and its terms shall not modify the applicable terms and conditions of the Purchase Agreement.

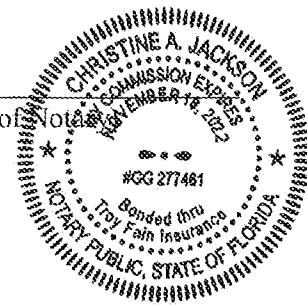
