RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of July 21, 2020, by Montage Capital II, L.P. ("Lender"), in favor of JBI Holding, Inc., a Delaware corporation ("JBI"), P.K. Kinder Co., Inc., a California corporation ("Kinder"), JR Kinder's Enterprises, Inc., a California corporation ("JRK"), and KCM Franchise Corp., a California corporation ("KCM"). JBI, Kinder, JRK and KCM are each referred to herein as a "Grantor" and collectively, as the "Grantors".

Recitals

WHEREAS Grantors granted to Lender a security interest in the intellectual property of Company, including without limitation the trademark items listed on Exhibit A attached hereto (collectively, the "Intellectual Property"), under an Intellectual Property Security Agreement dated as of September 6, 2017 (the "Security Agreement") which was recorded with the US Patent and Trademark Office on September 11, 2017 at the USPTO at Reel Number 6151 and Frame Number 0328.

WHEREAS Grantors have no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property.

Agreement

NOW THEREFORE, Lender hereby agrees that the Security Agreement is terminated and Lender terminates and releases its security interest in the Intellectual Property and reassigns to Grantors, without warranty or recourse, all interest of Lender in the Intellectual Property.


