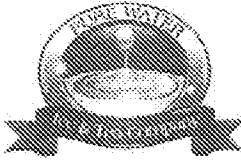

For purposes of this Agreement, the mark shall be referred to as the "Mark."


Assignee desires to acquire the Mark, the goodwill associated with the Mark, and the federal registration of the Mark.
