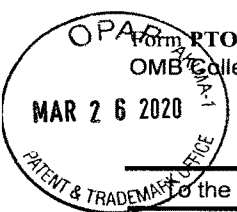

**ASSIGNMENT OF TRADEMARK**

B. Assignor has agreed to assign to the Assignee the above mentioned Trademark.


**NOW THEREFORE:**
