**SUPPLEMENTAL GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

THIS SUPPLEMENTAL GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Supplemental Grant") is made effective as of July 20, 2020, by and from **CLINICANYWHERE, LLC**, a Delaware limited liability company (the "Grantor"), to and in favor of **FRANKLIN SYNERGY BANK**, a Tennessee state bank (the "Grantee").

WHEREAS, Preferred Podiatry Management, LLC, an Illinois limited liability company ("Borrower"), Preferred Provider Group Lower Intermediate Holdco, LLC, a Delaware limited liability company ("Holdco"), and the Grantee are parties to that certain Credit Agreement dated as of August 15, 2018 (the "Original Credit Agreement"), as amended by (i) that certain First Amendment and Joinder to Credit Agreement and Loan Documents dated as of February 13, 2020 (the "First Amendment") by and among Borrower, Holdco, Polaris Health, LLC, a Delaware limited liability company ("Polaris Health"), and the Grantee, (ii) that certain Waiver and Amendment dated effective as of May 13, 2020 (the "PPP Amendment"), by and among Borrower, Holdco, Polaris Health, and the Grantee, and (iii) that certain Second Amendment and Joinder to Credit Agreement and Loan Documents dated as of even date herewith (the "Second Amendment", and the Original Credit Agreement, as amended by the First Amendment, the PPP Amendment, and the Second Amendment, and as it may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") by and among Borrower, Holdco, Polaris Health, the Grantor, Polaris Infection Control, LLC, a Delaware limited liability company, Assembly RCM, LLC, a Delaware limited liability company, and the Grantee.

WHEREAS, pursuant to the Second Amendment, the Grantor has become a party to the Guarantor Security Agreement (as such term is defined in the Credit Agreement).

WHEREAS, the Grantor owns the trademarks listed on Exhibit A attached hereto (the "Trademarks"), which Trademarks are registered with the United States Patent and Trademark Office.

WHEREAS, this Supplemental Grant is being executed in conjunction with grant of the security interest to the Grantee under the Guarantor Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in the Guarantor Security Agreement and the other Loan Documents, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Supplemental Grant are deemed to conflict with the Guarantor Security Agreement, the provisions of the Guarantor Security Agreement shall govern.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Definitions. All capitalized terms used but not defined herein shall have the respective meanings given to them in the Credit Agreement.

2. The Security Interest.

(a) This Supplemental Grant is made to secure the performance and payment of all the Obligations. Upon the payment in full of all Obligations, the Grantee shall promptly, upon such satisfaction, execute, acknowledge, and deliver to the Grantor all reasonably requested instruments in

writing releasing the security interest in the Trademarks acquired under the Guarantor Security Agreement and this Supplemental Grant.

(b) The Grantor hereby grants to the Grantee a security interest in (i) all of the Grantor's right, title and interest in and to the Trademarks now owned or from time to time after the date hereof owned or acquired by the Grantor, together with (ii) all proceeds of the Trademarks, (iii) the goodwill associated with such Trademarks and (iv) all causes of action arising prior to or after the date hereof for infringement of the Trademarks or unfair competition regarding the same.

3. Counterparts. This Supplemental Grant may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.

4. Governing Law. This Supplemental Grant and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of Tennessee.

IN WITNESS WHEREOF, the Grantor has executed this Supplemental Grant effective as of the date first written above.
