CERTIFICATE OF AMENDMENT
OF
SECOND AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
RSTUDIO, INC., A PUBLIC BENEFIT CORPORATION

RStudio, Inc., a public benefit corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said Corporation have duly adopted resolutions proposing and declaring advisable that the Second Amended and Restated Certificate of Incorporation of said Corporation be amended as follows:

RESOLVED: That the Board recommends and deems it advisable that the Second Amended and Restated Certificate of Incorporation of the Corporation be amended by deleting Article FIRST thereof in its entirety and inserting a new Article FIRST (the "Charter Amendment"), as follows:

"FIRST: The name of this corporation is RStudio,
PBC (the "Corporation")."

RESOLVED: That the Charter Amendment be submitted to the stockholders of the Corporation for their consideration.

RESOLVED: That, following the approval by the stockholders of the Charter Amendment as required by law, the officers of the Corporation be, and they hereby are, and each of them hereby is, authorized and directed to execute, deliver and file a Certificate of Amendment setting forth the Charter Amendment on behalf of the Corporation with the Secretary of State of the State of Delaware, and such officer's approval to be conclusively evidenced by the execution and delivery of such Certificate of Amendment.

SECOND: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of sections 228 and 242 of the General Corporation Law of the State of Delaware.
