**PLAN OF MERGER OF
SNUGGLE PET PRODUCTS LLC,
AND
DOGPERFECT, LLC,
INTO
ENCOMPASS PET GROUP, LLC**

Snuggle Pet Products LLC, a Florida manager-managed limited liability company, **DOGPerfect, LLC**, a Florida member-managed limited liability company, and **Encompass Pet Group, LLC**, a Florida manager-managed limited liability company, hereby adopt and approve the following plan as the Plan of Merger required by Section 605.1022, Florida Statutes. The terms of the Plan of Merger are as follows:

1. The names of the business entities planning to merge are Snuggle Pet Products LLC, a Florida manager-managed limited liability company ("**Snuggle Pet**"), DOGPerfect, LLC, a Florida member-managed limited liability company ("**DOGPerfect**"), and Encompass Pet Group, LLC, a Florida manager-managed limited liability company ("**Encompass**"). As a result of the merger, Snuggle Pet and DOGPerfect shall be merged with and into Encompass. Encompass shall be the surviving business entity.
2. The merger shall be effective on the date the Articles of Merger are filed with the Department of State (the "**Effective Date**").
3. As a result of the merger, the sole membership interest in Snuggle Pet and DOGPerfect shall be cancelled. No change shall occur in the membership interest of Encompass.
4. The name and address of the Manager for Snuggle Pet is Robert Emery, 796 Marbury Lane, Longboat Key, Florida 34228.
5. The name and address of the Managing Member for DOGPerfect is Robert Emery, 796 Marbury Lane, Longboat Key, Florida 34228.
6. The name and address of the Manager for Encompass is Robert Emery, 796 Marbury Lane, Longboat Key, Florida 34228.
7. This Plan of Merger shall be submitted to the Members and Managers of Snuggle Pet, DOGPerfect, and Encompass for approval.

8. The Members of Encompass having a membership interest in Encompass immediately prior to the Effective Date will hold the same membership interest, with identical designations, preferences, limitations, and relative rights, immediately after the merger.

9. The Members and Managers of Snuggle Pet, DOGPerfect, and Encompass are hereby authorized to amend this plan at any time prior to the filing of the Articles of Merger, to the extent permitted by law.

10. There are no other terms of or conditions to the merger.
