- Grant of Security Interest dated January 10, 2018, which was recorded in the United States Patent and Trademark Office on January 12, 2018 at **Reel 6249 and Frame 0187**, pursuant to which Grantor granted to Secured Party a security interest in certain trademark rights (the “Second Mark”), including the trademark registration listed on Schedule B attached hereto.




