**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 22 day of July 2020, by **STERLING NATIONAL BANK**, a national banking association ("Lender"), as Lender under that certain Loan and Security Agreement dated September 29, 2017, between **DONSCO, INC.** and Lender.

WHEREAS, reference is made to a certain Patent, Copyright and Trademark Security Agreement dated September 29, 2017 ("IP Security Agreement"), by **DONSCO, INC.**, a Pennsylvania corporation ("Grantor"), in favor of Lender which was recorded with the United States Patent and Trademark Office on October 3, 2017, in the Trademark assignment records under Reel/Frame Number 6171/0916, a copy of which is provided as Exhibit A hereto; and

WHEREAS, all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the IP Security Agreement; and

WHEREAS, pursuant to the IP Security Agreement, Grantor granted Lender a continuing security interest in all of the right, title and interest of Grantor in and to the Intellectual Property Collateral identified therein.

NOW THEREFORE, for good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably and forever releases, relinquishes, discharges and terminates any and all liens and security interests in and to the Intellectual Property Collateral arising thereunder including, without limitation, the intellectual property and other materials described in Schedule 1 hereto, and reassigns, regrants and reconveys to Grantor any and all interest in, to, and under the Intellectual Property Collateral, in each case granted pursuant to the IP Security Agreement, without recourse or representation or warranty, express or implied, of any kind or nature whatsoever. Further, Lender understands and agrees that this Release may be

recorded by, or for, Grantor with the United States Patent and Trademark Office and any other similar office or agency throughout the world.

This Release shall be governed by and construed in accordance with the laws of the State of Texas.
