**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of July 27, 2020, is made by **GOLUB CAPITAL MARKETS LLC**, a Delaware limited liability company, in its capacity as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”) in favor of **JAMF SOFTWARE, LLC**, a Minnesota limited liability company (“Pledgor”). Capitalized terms used but not defined herein have the respective meanings given to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, Pledgor, the Collateral Agent, and certain other parties entered into a Security Agreement, dated as of November 13, 2017 (as may have been amended, restated, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the “Security Agreement”), pursuant to which Pledgor executed and delivered that certain Trademark Security Agreement dated as of November 13, 2017 in favor of the Collateral Agent (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on November 14, 2017, in its records at Reel/Frame 6204/0680;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties, as collateral security for the payment and performance in full of all of the Secured Obligations, a first priority Lien on and a security interest in all of the right, title and interest of the Pledgor in, to and under the following (but excluding any “intent to use” Trademark application for which a Statement of Use or Amendment to Allege Use, as applicable, has not been filed and accepted with the United States Patent and Trademark Office, and any other Excluded Property): all Trademarks, including, without limitation, the United States registered Trademarks and applications for Trademark registration listed on Schedule 1 attached hereto, together with any and all (i) rights and privileges arising under applicable Legal Requirements with respect to the use or ownership of any of the foregoing, (ii) goodwill associated therewith, (iii) continuations, extensions and renewals thereof and amendments thereto, and (iv) Proceeds of any and all of the foregoing (the “Trademark Collateral”); and

WHEREAS, the Pledgor desires the Collateral Agent to release its Lien on and security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby terminates, cancels and releases its Lien on and security interest in the Trademark Collateral, and hereby re-assigns to the Pledgor any right, title or interest it may have in or to the Trademark Collateral, in each case without recourse to the Collateral Agent and without representation or warranty of any kind.

The Pledgor (and any successor to the Pledgor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral) is hereby authorized to record this Release with the United States Patent and Trademark Office.
