TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (“**Agreement**”) is dated June 24, 2020 (the “**Effective Date**”) and is between Artisan Confections Company, a corporation organized under the laws of Delaware, USA (“**Assignor**”) with an address of 8001 Arista Place, Suite 430, Broomfield, Colorado 80021, USA, and SBD Acquisition Company LLC, a limited liability company organized under the laws of Wisconsin, USA (“**Assignee**”) with an address of 1212 West Glen Oaks Lane, Mequon, Wisconsin 53092, USA.

Under that certain Asset Purchase Agreement, dated June 24, 2020 (the “**APA**”), by and between Assignee, Assignor, and, by joinder as to certain specified sections, The Hershey Company, a Delaware corporation, Assignor has agreed to assign to Assignee all of Assignor’s right, title, and interest in and to the trademarks set forth below in **Schedule A**, together with the goodwill of the business connected with the use of, and symbolized by, the trademarks (collectively, the “**Assigned Trademarks**”).

Assignee desires to acquire all of Assignor’s rights in the Assigned Trademarks in accordance with and subject to the terms of the APA.

In exchange for the consideration paid under the APA, the receipt of which is hereby acknowledged, Assignor does hereby sell and irrevocably transfer, convey and assign unto Assignee all of Assignor’s right, title, and interest in and to (a) the Assigned Trademarks, together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks, (b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world, (c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing, and (d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages. Assignor hereby authorizes and requests the Commissioner of the United States Patent and Trademark Office, and the corresponding entity or agency in any applicable foreign country, to record Assignee as assignee and owner of the Assigned Trademarks.

In accordance with and subject to the terms of the APA, Assignor agrees to execute and deliver such other documents and to take all such other actions which Assignee may reasonably request to effect the terms of this Agreement, and to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens, and other documentation as may be reasonably required to effect the terms of this Agreement and its recordation in relevant trademark offices.

This Agreement shall be construed and interpreted in accordance with the APA. In case of any conflict between the terms and conditions of this Agreement and the terms and conditions of

the APA, the terms and conditions of the APA will govern. This Agreement and all claims, disputes and Actions (as defined in the APA) will be governed by, enforced and construed in accordance with the laws of the State of Delaware and of the United States, regardless of the laws that might otherwise govern under applicable principles of choice of law or conflicts of law. This Agreement may only be amended, modified, or supplemented by a written agreement executed by an authorized representative of the Seller and the Buyer.

This Agreement shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors and assigns.
