## TERMINATION OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

This **TERMINATION OF SECURITY INTEREST** (this "Termination") is executed and delivered as of May 29, 2020, by and between Zanker Road Resource Management, Ltd., a California limited partnership with its principal place of business at 1500 Berger Road, San Jose, California 95112, as grantor (the "**Grantor**") and Bank of the West, a California banking corporation, acting in its capacity as administrative agent (the "**Administrative Agent**").

### PRELIMINARY STATEMENT

**WHEREAS**, the Grantor is the owner of record of the trademarks and applications listed on the attached Exhibit A, now issued or pending in the United States Patent and Trademark Office (the "Trademarks"); and

**WHEREAS**, the Grantor entered into that certain Security Agreement, dated as of November 1, 2013 (as amended, modified, extended, restated, renewed, replaced or supplemented from time to time, the "Security Agreement"), by and among the Grantor, the Administrative Agent in its capacity as administrative agent for the "Secured Creditors" as such term is defined in the Credit Agreement referenced therein; and

**WHEREAS**, pursuant to the Security Agreement, the Grantor has granted a continuing security interest in and continuing lien upon the trademarks and trade applications shown on Exhibit A attached hereto to the Administrative Agent for the benefit of the Secured Creditors, a true and correct copy of which was recorded by the United States Patent and Trademark Office on January 28, 2014, at Ree1 5202, Frame 0970; and

**WHEREAS**, the Grantor has discharged its obligations under the Security Agreement effective April 1, 2020; and

**WHEREAS**, the Administrative Agent, on behalf of the Secured Creditors, desires to release its security interest in the Trademarks and Patents and terminate the Security Agreement;

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, it is hereby agreed as follows:

### TERMINATION

The Administrative Agent hereby acknowledges and agrees that the Grantor has discharged its obligations pursuant to the Security Agreement as of April 1, 2020. Pursuant to Section 11(a) of the Security Agreement, the Administrative Agent acknowledges and agrees that all of the rights of the Secured Creditors under the Security Agreement have been terminated as of April 1, 2020.

The Administrative Agent hereby:

1. Releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of the Administrative Agent and Secured Creditors pursuant to the Security Agreement in the trademarks and applications more fully described on Exhibit A, without recourse or representation or warranty, express or implied; and

2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.

The Administrative Agent and the Grantor confirm that there are no outstanding obligations under the Credit Agreement and no further obligations thereunder owing from either party. The Administrative Agent and the Grantor hereby terminate the Security Agreement effective as of April 1, 2020.
