RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of July 23, 2020 (“Effective Date”) by ORIX GROWTH CAPITAL, LLC, a Delaware limited liability company, in its capacity as Agent (“Agent”) in favor of PORCH.COM, INC., a Delaware corporation (“Porch”), DONE.COM HOLDINGS, INC., a Texas corporation (“Done Holdings”), GOSMITH, INC., a Delaware corporation (“GoSmith”), INSPECTION SUPPORT LIMITED LIABILITY COMPANY, a Nevada limited liability company (“Inspection Support”), GUARDIAN SMALL BUSINESS CONSULTING AND FINANCIAL SERVICES LLC, an Idaho limited liability company (“Guardian”), SERVIC.COM, INC., a California corporation (“Serviz”), and HIRE A HELPER LLC, a California limited liability company (“Helper”; Porch, Done Holdings, GoSmith, Inspection Support, Guardian, Serviz and Helper each, individually, a “Grantor” and, collectively “Grantors”).

WHEREAS, pursuant to the terms and conditions of (a) that certain Intellectual Property Security Agreement, dated as of September 1, 2017, (b) that certain Intellectual Property Security Agreement, dated as of November 1, 2018 (c) that certain Amended and Restated Intellectual Property Security Agreement, dated December 5, 2018, and (d) that certain Supplement to Amended and Restated Intellectual Property Security Agreement, dated March 28, 2019 (collectively the “IP Security Agreements”), each by one or more of the Grantors in favor of the Agent, the Grantors granted to Agent a continuing security interest in and to all of the Grantors’ right, title and interest, in, to and under the United States trademark registrations and applications listed on the attached Schedule 1 (the “Intellectual Property”);

WHEREAS, the IP Security Agreements were recorded with the United States Patent and Trademark Office on (a) September 6, 2017 at Reel/Frame 6148/0493, (b) November 2, 2018 at Reel/Frame 6513/0957, (c) December 5, 2018 at Reel/Frame 6495/0244 and (d) June 11, 2019 at Reel/Frame 6667/0231; and


WHEREAS, the Agent wishes to terminate the IP Security Agreements and release and restore all right, title and interest in and to the Intellectual Property to the Grantors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates, cancels and releases any and all security interests or liens it has against the Intellectual Property, and all of the goodwill of the business connected with the use of, and symbolized by the Intellectual Property, and grants, assigns and conveys without recourse or warranty, to the Grantors all of their rights, title and interest in the Intellectual Property.
