

TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT, (hereinafter, the "Trademark Assignment Agreement") is dated the 29th day of May, 2020 (the "Assignment Effective Date"), and is by and between (a) Lumen Technologies, LLC, a Minnesota Limited Liability Company, having an address at 1010 Dale St. N., Saint Paul, MN 55117-5603 ("Assignee"), and (b) Lumen App Limited, a United Kingdom Private Limited Company, having an address of The Broadgate Tower, Third Floor, 20 Primrose Street, London, United Kingdom EC2A 2RS ("Assignor") (each, a "Party," and collectively, the "Parties").

WHEREAS, the Parties are subject to, and this Trademark Assignment Agreement incorporates by reference and is governed under, that certain Master Trademark Agreement dated May 29, 2020, by and between Lumen App Limited; Lumen Technologies, LLC; and Worldwide Vision Limited;

WHEREAS, capitalized terms in this Trademark Assignment Agreement shall have the meanings ascribed to them in the Master Trademark Agreement, if not separately defined herein;

WHEREAS, Assignor owns the trademarks, trademark applications and trademark registrations for LUMEN and marks containing LUMEN for goods and services in International Classes 9, 35, 38, and 41 as shown in Exhibit 1 to Trademark Assignment attached hereto (hereinafter collectively the "Assigned Lumen Marks"), and desires to irrevocably sell, assign, transfer and convey all of such rights worldwide to Assignee; and

WHEREAS, Assignor owns the trademarks, trademark applications, and trademark registrations for LUMEN and marks containing LUMEN for goods and services in International Class 45 (and, in jurisdictions that do not recognize International Class 45 as a classification of services, also including the services corresponding to those in International Class 45 irrespective of the class number for such services in such jurisdictions), including as shown in Exhibit 2 to this Trademark Assignment Agreement attached hereto (hereinafter collectively the "Retained Lumen Marks"), and desires to retain ownership of all such rights worldwide.

NOW, THEREFORE, for and in consideration of the foregoing recitals which are included as part of this Trademark Assignment Agreement and of the mutual covenants, promises and agreements hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties covenant, promise and agree as follows:

1. WARRANTIES

Assignor warrants that it owns all right, title, and interest in and to the Assigned Lumen Marks free and clear from any ownership claims from third parties; that it has not sold, licensed, or transferred any rights or interest in the Assigned Lumen Marks to a third party, and that it is not under any obligation to perform any of the foregoing; that it has the authority to enter into this Trademark Assignment Agreement; and that there are no permissions that are required to be

obtained in order for the assignments contemplated in this Trademark Assignment Agreement to be complete and fully vest in Assignee.

2. TRADEMARK ASSIGNMENT

- (a) Effective as of the Assignment Effective Date, and in consideration for the Purchase Price paid to Assignor, Assignor hereby irrevocably sells, assigns, transfers, and conveys to Assignee all of Assignor's rights, title, and interest in the Assigned Lumen Marks, together with the goodwill of the portion of the business symbolized thereby and the right to sue, oppose others, file cancellation actions, collect for past damages for trademark infringement and trademark-related unfair competition (collectively, "Assigned Mark Rights"). The Assigned Mark Rights shall also include any and all common law rights outside of Class 45 and any active trademark applications or registrations filed anywhere in the world by Assignor for the Assigned Mark Rights or any mark or name containing the term LUMEN in any International Class of goods and services other than Class 45 as of the Assignment Effective Date. The parties understand that trademark applications may need to be divided to allow the Assigned Mark Rights to be assigned to Assignee. The Assigned Mark Rights being assigned in this Trademark Assignment Agreement are being assigned to Assignee without any warranties or representations being made regarding their seniority or potential for alleged infringement with respect to third parties.
- (b) In the event a particular jurisdiction does not allow a multi-class trademark application or registration to be divided by class to effect the assignment and retention of rights contemplated in the Master Trademark Agreement or this Trademark Assignment Agreement (that is, Assignor's retention of all rights, applications, and registrations in and to Class 45), or in the event a particular jurisdiction does not allow separate ownership of the Assigned Lumen Marks and the Retained Lumen Marks:
 - (i) Assignor will assign such applications or registrations for the Retained Lumen Marks in said jurisdiction to Assignee or its Designee in a separate assignment agreement under terms substantially similar to those contained in this Trademark Assignment Agreement; and
 - (ii) Assignee or its Designee will grant Assignor or its Designee a perpetual, irrevocable, royalty-free, fully paid-up, and exclusive license back to use the Class 45 services in that jurisdiction in a separate license agreement, consistent with the requirements of the Master Trademark Agreement, including without limitation Section 2 of that agreement.

3. COOPERATION WITH REGISTRATION

(a) In the event any trademark application(s) or registration(s) for the Assigned Mark Rights cannot be immediately assigned as of the Assignment Effective Date, Assignor hereby grants to Assignee an irrevocable, fully paid-up, royalty-free unlimited, exclusive, sublicenseable, fully-transferrable license to use such mark that is the subject of such application or

registration, and agrees to assign such trademark application or registration at such time when it is eligible under law to be assigned.

(b) Assignor agrees to cooperate with Assignee in its efforts to register the Assigned Mark Rights, dividing registrations covering Assigned Lumen Marks and Retained Lumen Marks, and recording the assignment of the Assigned Mark Rights, at Assignee's expense and with Assignee to pay or reimburse all of Assignor's reasonable costs and expenses (including attorney's fees), including providing a requested letter of consent to register the Assigned Mark Rights, amending or deleting goods or services in Assignor's applications or registrations for the LUMEN Marks except in Class 45, or temporarily assigning applications or registrations to the other Party until registration at which time the application or registration would be assigned back.

4. FURTHER ASSURANCES

Each Party shall cooperate with the other Party, at such other Party's cost, including assisting in the execution and delivery of such further and additional assignments, confirmatory assignments, consents, letters of consent to trademark offices, and other documents that may be requested, in order to give effect to the intent and terms of this Trademark Assignment Agreement.

5. AUTHORITY TO BIND PARTIES

The persons signing below warrant that they have the authority to execute this document on behalf of the respective principals, entities, corporations, partnerships, or for themselves individually. Further, each Party has full legal power and authority to enter into and perform this Trademark Assignment Agreement in accordance with its terms.

6. GOVERNING LAW AND JURISDICTION

This Trademark Assignment Agreement, including any non-contractual obligations arising out of or in connection with this Trademark Assignment Agreement, is governed by and shall be construed in accordance with English law and the Parties hereby submit to the exclusive jurisdiction of the English courts in the event of any dispute relating to this Trademark Assignment Agreement or any non-contractual obligations arising out of or in connection with this Trademark Assignment Agreement.

Assignee appoints Marks & Clerk of 15 Fetter Lane, London EC4A 1BW, United Kingdom as its agent to receive on its behalf in England service of any legal proceedings arising out of or in connection with this Trademark Assignment Agreement. Assignor appoints Pinsent Masons LLP of 30 Crown Place, Earl Street, London EC2A 4ES, United Kingdom as its agent to receive on its behalf in England service of any legal proceedings arising out of or in connection with this Trademark Assignment Agreement. Such service shall be deemed completed on delivery to such agents (provided the Party upon whom service is to take place is also notified as required by Section 7 below) and shall be valid until such time as the serving Party has received prior written notice that such agent has ceased to act as agent and has received valid notice of a

valid substitute agent. If for any reason such agents cease to be able to act as agent for their respective Party or no longer has an address in England, such Party shall forthwith appoint a substitute acceptable to the other Party and deliver to the other Party the new agent's name and address within England. Assignee and Assignor irrevocably consent to any process in any legal action or proceedings arising out of or in connection with this Trademark Assignment Agreement being served on each in accordance with this clause. Nothing contained in this Trademark Assignment Agreement shall affect the right to serve process in any other manner permitted by law.

7. NOTICES

All notices required or permitted to be made or given pursuant to this Trademark Assignment Agreement shall be in writing and shall be sent to the receiving Party by both national courier (e.g., Federal Express, UPS, DHL) and email, as follows until otherwise updated by either Party in their sole discretion by providing the other Party with written notice thereof:
