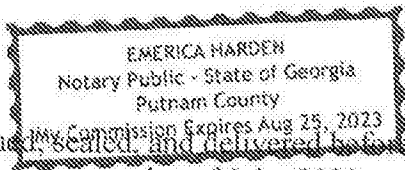
WHEREAS, Assignor is the owner of the trademarks listed in Schedule A attached hereto (the "Trademarks"); and

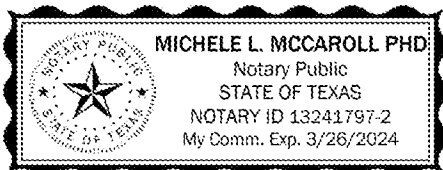

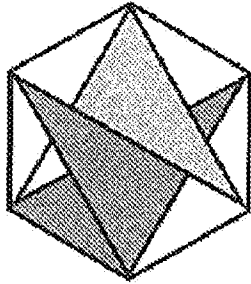
