**TERMINATION AND RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of July 29, 2020, is made by BYLINE BANK, an Illinois banking corporation, as the administrative agent and collateral agent for the Lenders ("Agent"), under that certain Trademark Security Agreement, dated as of January 31, 2018, by QUALITY IMPORTERS TRADING COMPANY, LLC, a Delaware limited liability company, THE BIG EASY TOBACCO COMPANY, LLC, a Delaware limited liability company, ORLEANS GROUP, LLC, a Florida limited liability company, and XIKAR, INC., a Kansas corporation (collectively, the "Grantors," and each, individually, a "Grantor"), in favor of Agent (as amended, supplemented or modified and in effect from time to time, the "IP Security Agreement"). Capitalized terms used but not defined herein shall have the meanings set forth in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, Grantor granted a security interest to Agent (for benefit of the Lenders) in certain intellectual property collateral including, among others, the Trademark "CULT" more particularly described on Exhibit A attached hereto (such Trademark, the "Released Collateral"); and

WHEREAS, an executed copy of the IP Security Agreement was recorded with the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office on May 8, 2018 at Reel 6369, Frame 0371; and

WHEREAS, Agent has agreed to terminate and release its security interest in the Released Collateral only.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the Released Collateral only, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Released Collateral.
