RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the "Release") is dated as of July 17, 2020 by MORGAN STANLEY SENIOR FUNDING, INC., as collateral agent (in such capacity and together with its successors, the "Collateral Agent"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement (as defined below).

WITNESSETH

WHEREAS, BILLING CONCEPTS, INC., a Delaware corporation (the "Grantor") and the Collateral Agent entered into that certain Pledge and Security Agreement dated as of December 19, 2007 (the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantor executed and delivered to the Collateral Agent that certain Trademark Security Agreement dated as of December 19, 2007 (as amended, restated, supplemented or otherwise modified, the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office on January 7, 2008 at Reel/Frame No. 3690/0607, pursuant to which the Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties, a security interest in all of its Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Pledge and Security Agreement and the Trademark Security Agreement.
