1. The current name of the Corporation is Bellhops, Inc. The Corporation's original Certificate of Incorporation was filed with the Delaware Secretary of State on July 23, 2014, under the name Campus Bellhops, Inc. The Company's Amended and Restated Certificate of Incorporation was filed with the Delaware Secretary of State on December 5, 2018 (the "**Restated Certificate**").

2. The Company's Restated Certificate was further amended upon filing of a Certificate of Amendment with the Delaware Secretary of State on April 7, 2020 (the "**Current Certificate**").

3. This Certificate of Amendment to the Current Certificate to change the name of the Corporation has been duly approved by the Corporation's Board of Directors in accordance with Sections 141 and 242 the Delaware General Corporation Law.

4. This Certificate of Amendment to the Current Certificate to change the name of the Corporation has been duly approved by the required vote of stockholders in accordance with Sections 228 and 242 of the Delaware General Corporation Law.

5. Article FIRST of the Current Certificate is hereby amended to read as follows:

"FIRST: The name of this corporation is Bellhop, Inc. (the "**Corporation**")."
