## NOTICE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This Notice of Intellectual Property Security Interest (this "Notice") is entered into and effective as of July 31, 2020, by and between **COMBAT BRANDS, LLC**, a Kansas limited liability company (including its successors by way of amalgamation, "Grantor"), and **CROSSFIRST BANK**, a Kansas state-chartered bank (together with its successors and assigns "Grantee") (collectively, the "Parties").

For the avoidance of doubt, if the terms of this Notice conflict with the Security Agreement, the terms of the Security Agreement shall govern.

3. This Notice may be executed in counterparts, each of which shall constitute an original and all of which shall, when taken together, constitute one and the same agreement, notwithstanding that all parties may not have signed all counterparts of this Notice.
