TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** this “**Termination and Release**”) is granted as of July 31, 2020 by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as agent for the Lenders Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, “**Wells Fargo**”), in favor of **CHAMPION LABORATORIES, INC.**, a Delaware Corporation (the “**Grantor**”).

WHEREAS, pursuant to the Credit Agreement dated as of December 30, 2016, (as amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among the Grantor, certain affiliates of the Grantor, and Wells Fargo (amongst others), the Grantor executed and delivered to Wells Fargo a Trademark Security Agreement dated as of December 30, 2016 (the “**Trademark Security Agreement**”), granting Wells Fargo a security interest in and lien on the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“**USPTO**”) on January 3, 2017, at Reel 5956, Frame 0400;

WHEREAS, the Grantor has requested that Wells Fargo terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademark Collateral, including the trademarks as fully described on the attached Schedule I as herein provided; and

WHEREAS, the Grantor has requested that Wells Fargo provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo hereby states as follows:

1. **Release of Security Interest.** Wells Fargo hereby (i) terminates the Trademark Security Agreement, (ii) reassigns any and all interest it may have in the Trademark Collateral to Grantor, and (iii) and releases, terminates and discharges fully all of its liens and security interests in the Grantor's right, title and interest in, to and under the Trademark Collateral, including the trademarks set forth in Schedule I, and all goodwill associated therewith, without recourse or representation or warranty, express or implied, of any kind.

2. **Recordation.** Wells Fargo authorizes and requests that this Termination and Release be recorded at the USPTO by the Grantor.

3. **Further Assurances.** Wells Fargo agrees to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, in each case, at the Grantor's expense, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Termination and Release.

4. **Governing Law.** This Termination and Release and the rights and obligations of the parties under this Termination and Release shall be construed in accordance with and governed by the law of the State of New York, without regard to any principle of law that could require the application of any other law.

5. **Counterparts.** This Termination and Release may be executed in any number of counterparts and by different parties on separate counterparts, each of which, when executed and delivered, shall be deemed to be an original, and all of which, when taken together, shall constitute but one and the same this Termination and Release. Delivery of an executed counterpart of this Termination and Release by telefacsimile or other electronic method of transmission (including ".pdf" or ".tif" format) shall be equally as effective as delivery of an original executed counterpart of this Termination and Release. Any party delivering an executed counterpart of this Termination and Release by telefacsimile or other electronic method of transmission also shall deliver an original executed counterpart of this Termination and Release but the failure to deliver an original executed counterpart shall not affect the validity, enforceability, and binding effect of this Termination and Release.


