## TRADEMARK ASSIGNMENT AGREEMENT

This Assignment includes without limitation: all applications and registrations for the Trademarks; all related common law rights; all related priority rights or claims based on international conventions; all rights to proceeds of the Trademarks, including income, royalties, damages, profits, and payments now or hereafter payable; and the right to take action against third parties for past, present, or future infringement of the Trademarks.
2. Assignor shall execute and deliver any other documents and perform any other reasonable acts Assignee may request, that Assignee considers necessary and appropriate to effect the terms of this Assignment and establish Assignee's rights in the Trademarks.
3. This Assignment binds and inures to the benefit of the respective successors and assigns of Assignor and Assignee.
