THIS CONFIRMATORY DEED OF ASSIGNMENT is made and entered into this 16th day of JULY 2020, but to be effective as of 1 June 2020 (the "Effective Date")

BETWEEN:

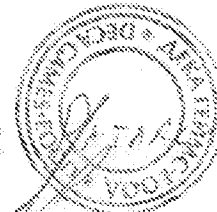
- (1) **Bee Square, S.L.**, a company registered in Spain (company registration no. ES865770323) whose registered office is at Rambla de Catalunya, 35, PPAL 2a, 08007, Barcelona, Spain (the "Assignor"); and
- (2) **DECA Games EOOD**, a company incorporated in Bulgaria (company registration no. 205081825) whose registered office is at 15 Teanko Tserkovski Str., Veliko Tarnovo 5000 Bulgaria (the "Assignee").

WHEREAS:

- (A) The Assignor has assigned to the Assignee the trade marks (the "Marks"), short particulars of which are set out in the Schedule to this agreement, by virtue of a Game Asset Purchase Agreement dated 1 June 2020.
- (B) The Parties wish to confirm and document the assignment of the Marks.

ASSIGNMENT

1. The Assignor hereby confirms having assigned, transferred and conveyed effective 1 June 2020 absolutely with full title guarantee to the Assignee all rights, titles and interests in and to the Marks together with all rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action.
2. The Assignor confirms that the assignment of the Marks was made with the goodwill attaching to and symbolised by the Marks.
3. The Assignor agrees that it shall (and shall use reasonable endeavours to procure that any necessary third party shall) at the request of the Assignee at all times hereafter do all such acts and execute and deliver such documents as may reasonably be necessary or desirable both to secure the vesting in the Assignee of all rights assigned to it in this agreement and to ensure the proper recordal of this assignment at the relevant Trade Mark Registries and to assist in the resolution of any question concerning the Marks.
4. The Assignor confirms that the Assignee is authorised to sign on behalf of the Assignor all forms and documents that are required by the relevant Trade Mark Registries to record this assignment at those Trade Mark Registries.





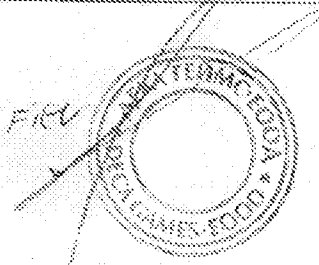
