**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is dated as of July 14, 2020 by JEFFERIES FINANCE LLC, as collateral agent (in such capacity, the "Collateral Agent"), in favor of TELADOC HEALTH, INC. (f/k/a Teladoc, Inc.), BEST DOCTORS, INC., HY HOLDINGS, INC., STAT HEALTH, LLC and RISE HEALTH, INC. (collectively, the "Grantors").

WITNESSETH

WHEREAS, the Grantors and the Collateral Agent entered into that certain Security Agreement dated as of July 14, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Grantors, the other grantors from time to time party thereto and the Collateral Agent;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered to the Collateral Agent that certain Grant of Security Interest in United States Trademarks dated as of July 14, 2017 (the "Intellectual Property Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on July 14, 2017 at Reel/Frame No. 6105/0816, pursuant to which the Grantors assigned, pledged and granted to the Collateral Agent, its successors and assigns, for the benefit of the Finance Parties (as defined in the Security Agreement), a security interest in all right, title and interest in or to all the Trademark Collateral (as defined in the Intellectual Property Security Agreement); and

WHEREAS, in connection with the payoff of the obligations secured by the Trademark Collateral, the Grantors have requested that the Collateral Agent release its security interest in all right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in or to any and all of the Trademark Collateral, including the registered trademarks and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement or the Intellectual Property Security Agreement.
