WHEREAS, it is a condition to the consummation of the transactions contemplated by the Agreement that the parties execute and deliver this Assignment;

NOW, THEREFORE, for the foregoing recited consideration and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Assignor does hereby assign unto the said Assignee all right, title and interest in and to the Marks, together with the good will of the business symbolized by the Marks, effective as of the date of the Agreement. Assignor does hereby further assign to Assignee any and all causes of action, claims, demands, or other rights occasioned from or because of any and all past infringements of said Marks, together with the right in Assignee to sue and recover therefore, including the right to bring suit in its own name.

Assignor further agrees, to the extent necessary and upon Assignee's request, to provide the respective foreign associates with powers of attorney sufficient to allow Assignee to take the steps necessary to transfer and record title.
